IMPORTANT INFORMATION

I highly recommend travel insurance in one form or another; you may purchase this with your registration from me, or from any provider. I feel it is essential as one never knows what might happen before or during the trip and coverage is your only opportunity to regain any loss from an unexpected event.

It is particularly important that should you decline the optional insurance, you **MUST** include a signed 'Decline Insurance' form which is included in the packet or your registration will not be processed.

Please be certain that you understand the terms and conditions found online as indicated by the link from the tour website regarding penalties and refunds. While registration to participate in the group air is due on August 20, the final payment deadline is September 20, 2008 for those registering on time. Should someone register after registration deadline (August 20) full payment is due at time of registration and is subject to availability. Airfare after August 20 cannot be guaranteed, but I will do my best to secure a similar rate as to the group rate once taxes are included. Group Air is limited and any remaining seats will be released after the August 20 date. Please register early to insure this airfare.

Once you have been registered, you are responsible for any and all penalties regardless of the reason of withdrawal from the program. Insurance is highly recommended.
